Administration continues to work with State and County agencies to develop a feasible project to improve this area.

# **Upcoming ODOT Projects in the Area**

93754: ALL/HAN IR 75 22.68/0.01 - Replace deck edges and overlay bridge decks and approach slabs on IR 75 bridges over Riley Creek, and overlay bridge deck on CR 15 bridge over IR 75. Fiscal Year 2018 Project is due to commence April 2. There will be some short-term closures of the Triplett Pathway to the Village Park as equipment is set-up for the bridge work.

# West Elm Improvement Project

Choice One has completed field survey work and have established preliminary roadway profile and cross sections for the reconstruction. They also field walked the project route to verify water service tie-in locations. We are currently reviewing the layout and sidewalk route. There will be some power pole relocations; the affected poles will be moved to the back of the right-of-way so as to not interfere with the sidewalk route. The next Public Meeting is projected mid-late April.
