We did it! We got permission from the Allen County Health Dept. to open up the Bluffton Senior Center! We do not have permission to run any programs other than the Toenail Clinic at this time. Here is a list of things that you may do at the Senior Center and the rules that need to be followed:

Shop: only four people in the store area at a time and masks are required.

Lending Library: returned materials must be put in the designated area where they will be kept for five days and then sanitized before returned to the shelves. Masks must be worn in the library area. Only one person in the book area at a time. Only one person in the puzzle area at a time.

Exercise equipment: We have two exercise bikes and a treadmill. They are very close together so only one person may use the equipment at a time. You may remove your mask while working out. Please let a staff person know when you are done so that the area may be sanitized before the next user.

Crafts: Please call ahead to let us know that you wish to come in and what you wish to work on. We will set up an area for you so that we can keep everyone distanced and safe. Masks must be worn until you are settled with your project and can properly social distance.

REMEMBER If you are sick or not feeling well or if you have been around someone who is showing symptoms of COVID 19 or if you are waiting on a COVID test or if you have been traveling out of state to a highly effected area, we ask that you refrain from coming into the Senior Center to help protect other members and the staff. 


