Pedestrian & Bike Pathway:

An ambitious goal: Encircle Bluffton with a Pedestrian and bike pathway.

In the fall of 2009, the Lions pledged \$4,500 to fund a pathway study. A plan was designed and accepted. The first phase connects Maple Crest and Riverbend areas to Bentley Road. Phase II hopes to connect the County Line road area to the I-75 restaurant area. Additional phases will follow.

The fundraising effort of the Charity Corvette Raffle program was developed in 2010 to help charities needing additional sources of revenue for programs. This fundraising program will assist in generating revenue for the pathway. This year the raffle has expanded to include 501 (c) (4) organizations.

Bluffton Lions have a long history of supporting Bluffton community projects. Chartered in 1934, the club will celebrate their 77th year at the February 15th charter anniversary meeting.
