**Subject: Downtown Sidewalk Safety Zone and Signage Recommendation**

## Purpose

The purpose of this memorandum is to present a recommendation to improve pedestrian safety within the Downtown Business District through the establishment of a Downtown Sidewalk Safety Zone supported by clear and consistent signage.

## Background

The Village of Bluffton has experienced a noticeable increase in the use of bicycles, electric bicycles, and electric scooters as modes of transportation. While these devices provide convenience and accessibility, their presence on downtown sidewalks has created safety concerns due to speed differentials between riders and pedestrians.

A recent capstone study found that many residents expressed concern about shared sidewalk use, 43.8% support requiring walking, and comments frequently cited excessive speed and near-misses. The study concluded that a walking-only requirement would improve safety outcomes. My recommended approach does not include a Dismount Zone and related Ordinance but establishes clear expectations of traveling speed on regulated sidewalks while allowing flexibility and community adaptation before any regulatory action.

## Recommendation

It is recommended that the Pathway Board support a phased implementation strategy beginning with the creation of a Downtown Sidewalk Safety Zone focused on community education without strict, enforceable regulations using well-placed signage and community-led enforcement. This strategy would be formalized by a Resolution by Village Council to create a Downtown Sidewalk Safety Zone with the installation of approved signage at approved locations.

## Proposed Downtown Sidewalk Safety Zone

Maximum Speed: 5 MPH

Pedestrian Priority: Pedestrians maintain full right-of-way

Rider Behavior: Riders are encouraged to Slow Down devices during high pedestrian activity

## Signage Plan

Install signage at entry points, mid-block locations, and high-conflict areas. Preferred messaging is on the following page with Option #3 or #4 being my recommendations. Option #3 will show dirt faster.

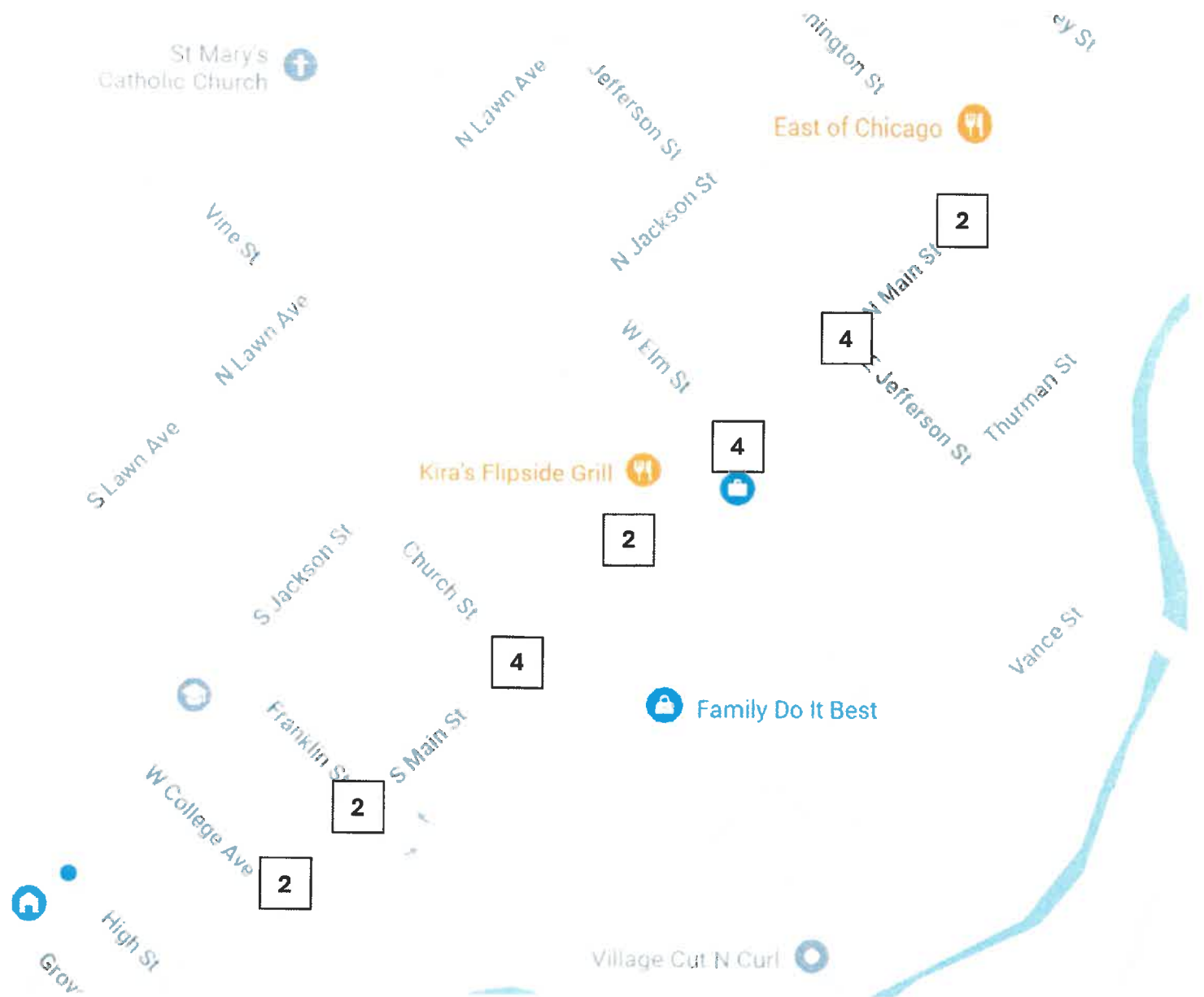


**Implementation Strategy** – begin with an education-first- approach

1. Install signage
2. Public awareness – use Farmer's Market to educate residents
3. Monitor conditions – provide feedback to Village Admin. To share w/ stakeholders
4. Evaluate after 6-12 months – a formal Dismount Zone Ordinance can be created if needed

## Conclusion

This is a practical, low-cost approach that aligns with community feedback and allows measured implementation before regulation. As stated before, this is Phase I of a strategy that can be tightened up in the future.

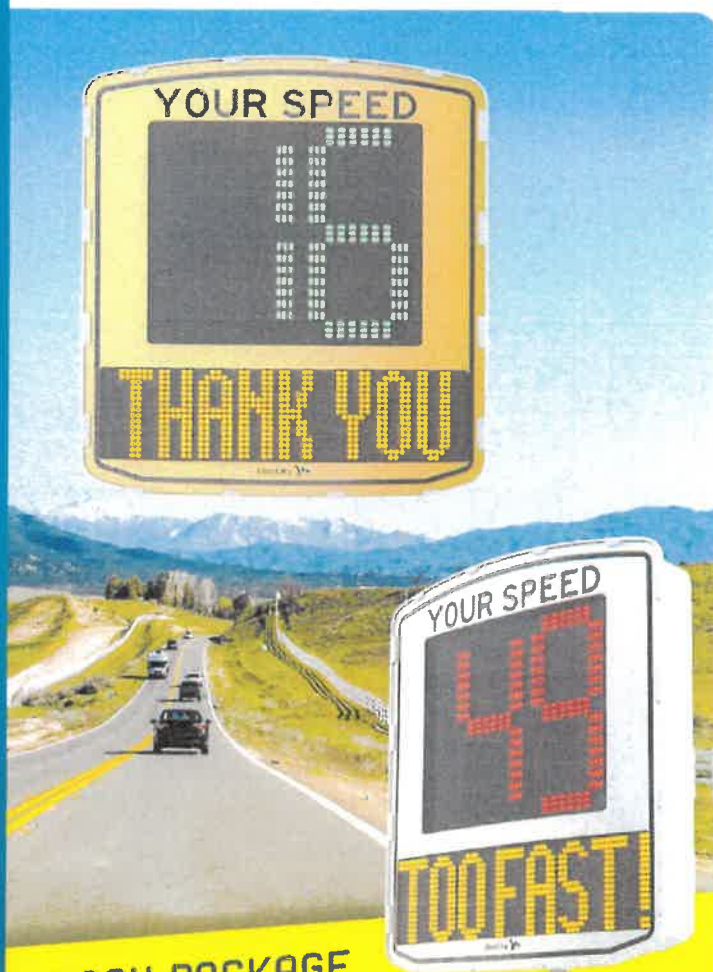

### **A RESOLUTION ESTABLISHING AND RECOGNIZING A DOWNTOWN SIDEWALK SAFETY ZONE WITHIN THE VILLAGE OF BLUFFTON, OHIO; AUTHORIZING THE INSTALLATION OF EDUCATIONAL SIGNAGE AND PAVEMENT MARKINGS RELATED TO BICYCLE, ELECTRIC BICYCLE, AND SCOOTER SAFETY**

**WHEREAS**, the Village of Bluffton has experienced increased use of bicycles, electric bicycles, electric scooters, and similar mobility devices within the Downtown Business District; and

**WHEREAS**, Village Administration, the Bluffton Pathway Board, the Streets, Alleys Lights and Sidewalk Committee along with members of the public have identified concerns regarding conflicts between pedestrians and riders utilizing downtown sidewalks; and

**WHEREAS**, a public survey and capstone study conducted regarding downtown sidewalk use found that many residents expressed concern regarding the speed and operation of bicycles and scooters on downtown sidewalks, including concerns regarding pedestrian safety, near-miss incidents, and rider speed; and

**WHEREAS**, the study further concluded that implementation of a walking-only expectation or related safety measures within the downtown sidewalk system would improve safety conditions for pedestrians and riders alike; and

**WHEREAS**, the Village of Bluffton desires to promote safe and courteous shared use of sidewalks through education, awareness, signage, pavement markings, and voluntary compliance measures prior to consideration of additional regulations; and

**WHEREAS**, the Village finds that establishment of a Downtown Sidewalk Safety Zone will promote public safety, improve pedestrian comfort, encourage responsible riding behavior, and support a welcoming downtown environment;

**NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Bluffton Ohio, that:**

**SECTION 1:** The Village of Bluffton hereby formally establishes and recognizes a “Downtown Sidewalk Safety Zone” generally encompassing the Downtown Business District and associated public sidewalks as determined appropriate by Village Administration.

- A. Pedestrians shall maintain priority and right-of-way on downtown sidewalks;

B. Operators of bicycles, electric bicycles, scooters, and similar devices are encouraged to travel at a safe and controlled speed not exceeding five (5) miles per hour while operating within the downtown sidewalk system;

C. Operators are encouraged to dismount and walk bicycles and scooters in congested or heavily utilized pedestrian areas; and

D. Operators shall exercise due care and courtesy toward pedestrians, businesses, outdoor dining areas, and downtown visitors.

**SECTION 4:** The Village Administrator is hereby authorized to install educational signage, pavement markings, decals, vinyl stickers, informational displays, and related public awareness materials promoting the Downtown Sidewalk Safety Zone and associated safety expectations.

**SECTION 5:** The Village Administrator is further authorized to coordinate with the Streets, Alleys, Lights and Sidewalk Committee, Bluffton Pathway Board, Bluffton Police Department, and other stakeholders regarding placement, design, public outreach, and future evaluation of the Downtown Sidewalk Safety Zone.
