Minutes of the December 1, 2016 meeting were approved as presented. Greg Denecker made the motion to approve; Jim Harder placed a second. Motion carried.

#### **BUSINESS:**

# Bluffton Lions Foundation Restricted Funds Available for Development of Bentley Rd. and Parkview Paths

Dick Ramseyer reported that the 1/5/17 balance in the restricted account of the Bluffton Lions Foundation is \$70,794.

#### **Proposed National and State Bicycle Route**

Mayor Judy Augsburger received a letter form the Ohio Department of Transpiration explaining that ODOT's "long range plan, Access Ohio 2040, is to coordinate efforts with local jurisdictions to designate Ohio's first U.S. and State Bike Route network. This network will be similar to the interstate and state route system of highways. ODOT intends to have five (5) U.S. bike routes and 18 state bike routes, and one or more of these proposed routes are planned to follow roadways or trails that are under your jurisdiction... ODOT's intent is to complete the designation of these routes during the spring of 2017." ODOT is working with the American Association of State Highway and Transportation Officials (AASHTO) on this endeavor. A copy of the letter and the accompanying maps were shared with the Pathway Board.

The letter goes on to request that the Village of Bluffton enact a resolution that says in part, "the Village of Bluffton hereby expresses its approval and support for the development of State and US Bicycle Routes, and requests that the appropriate officials see to it that the route is officially designated by AASHATO and the Ohio Department of Transportation." The Mayor informed Dick Ramseyer that the topic will be on the Council agenda on 1-9-17, at 8 pm.

Discussion followed. Fred Steiner made the following motion:

The Bluffton Bike and Pedestrian Pathway Board is excited that the state has included Bluffton in the state-wide long range plan for a State Bike Route network, and the Pathway Board expresses its support of the ODOT/AASHATO resolution and encourages Village Council to adopt it.

Mitch Kingsley placed a second. Motion carried unanimously.

## Augsburger Road Pathway Project

Mulching around eight (8) Masterpiece signs will be done by the Village this spring. Dick Ramseyer supplied mulching fabric, Dima Snyder supplied the rocks, and Bluffton Village will supply the labor.

Funds for the replacement of the recognition sign continue to come in. As of this date, \$870 of the \$1020 needed has been received by the Foundation from PB members. Upon final review of the

proposed replacement panel, it will be installed this month. The PB approved the final version.

#### Hancock Handlebars Bicycle Club (HHBC) 100 Mile Ride in 2017

The Hancock Handlebars Club is changing its route for the annual 100 mile ride in 2017. The Pathway Board and Lions Club have sponsored a rest stop in the past. The HHBC is asking if Bluffton could accommodate the group for the lunch break in 2017. Conversations have been had with the schools and the Lions Club about this possibility. When people pay the fee to join the ride, the cost of lunch is included.

## **Bentley Road Pathway**

Dick and Mitch met with the two homeowners most affected by the Bentley Rd. bike path on 12-13-16. These homes are located where Bentley Rd. has migrated west the most. The homeowners expressed a hope that the Pathway not extend beyond the current ROW, which allows only 4-5 feet beyond the current road/asphalt in that location. Various options were discussed including narrowing the road, narrowing the bike path, extending the road, etc. At this point in time, narrowing the path at this location seems to be the most feasible although a final decision was not made. Also discussed the telephone poles along Bentley and best options for managing placement of the poles when the bike path is added.

Discussed what steps are necessary for the project to continue to move forward. Jesse Blackburn, Village liaison, agreed to work on a sketch that clearly shows visually where the path will be placed. The PB will review this at the next meeting. In March, the PB will take this sketch along with the estimate provided by Don Snyder to the Village Streets and Alleys Committee meeting. Don's estimate is based upon the pathway being an extension of the road, i.e. no grass between the road and the bike path.

It was noted again at this meeting that, in order to pursue fund raising, it will be important to know the Village financial plan and timeline for including Bentley Road in the Village Connectivity Plan.

#### Parkview Subdivision Pathway Project

Construction of the 8 foot path connecting Kibler Street to Parkview will take place this spring. Dan Snyder expects the only variable in the estimate to be the price of asphalt.

Discussed placement of pathway marker signs in Parkview Subdivision. The group was reminded that in Parkview, the cement sidewalks will be enlarged from 4 feet to 6 feet (rather than 8 feet), and they will be installed as the houses are built. Discussed whether or not we should place our typical marker at each spot where the cement sidewalk crosses a street in Parkview. This then lead into a discussion of whether or not the 6 foot cement sidewalk then becomes the responsibility of the Village to maintain as the Village does other designated bike paths. Also discussed whether street signs designating the street as the bike path was an option. Discussion was held with no conclusion drawn.

One donor recognition sign will be erected at the Kibler Street connector. Proposed signage was reviewed, but not finalized.

#### **Annual Bids**

We received one bid for the aggregate and asphalt material, asphalt application and equipment rental from Bluffton Stone Co. / Bluffton Paving Co. and three bids for the Installation and Excavation from All Terra Inc., Beaverdam Contracting Inc., and Gary Lugibihl Excavating for the 2017 Construction Year. Resolution No.s 04-17and 05-17 are Resolutions accepting all of these bids for 2017 Construction Year.

#### **Brush Grinding**

We received three quotes for grinding the material at the brush dump: Re:Source Recycling submitted an estimate of \$7,000.00; Tawa Mulch and Landscape Supply submitted an estimate of \$8,653.00; and Park Enterprise Construction Co. submitted an estimated of \$15,000.00. At this time, I am recommending that Council accept the estimate from Re:Source Recycling for \$7,000.00 to perform the grinding.

## Park Grant Application

Resolution No. 03-17 is a resolution to permit the Village to apply for funding through the Johnny Appleseed Metropolitan Park District's 2017 Cooperative Park Improvement Grant Program. The Village will be applying for funds to assist with upgrades to park amenities and structures at the Village Park and the Buckeye Park.

#### **Assessment Monitoring**

We received notification today from the US EPA that our system has been selected for Assessment Monitoring under the next Unregulated Contaminants Monitoring Rule (UCMR 4). Per the notification, "Under the UCMR 4, randomly selected community water systems and non-transient, non-community water systems serving less than 10,000 or fewer persons are selected to monitor for unregulated contaminants. EPA will supply your system with the sampling kits and instructions for their use. In some situations, State personnel will do the sampling for your system. Unless you are advised that this is the case, you will be responsible for collecting the samples per EPA's instructions. EPA will pay for the cost of shipping the samples to an EPA-designated laboratory as well as the cost of analysis." The letter states that more information should be forthcoming. Based on the information detailed at epa.gov/dwucmr/fourth-unregulated-contaminant-monitoring-rule, it appears that the monitoring will take place sometime between March 2018 and December 2020.
