#### ORDINANCE NO. 18-15

## AN ORDINANCE TO AMEND ORDINANCE NO. 17-05 OF THE VILLAGE OF BLUFFTON, OHIO REGARDING MUNICIPAL INCOME TAX

WHEREAS, the Home Rule Amendment of the Ohio Constitution, Article XVII, Section 3, provides that "Municipalities shall have authority to exercise all powers of local self-government," and the municipal taxing power is one of such powers of local self-government delegated by the people of the State to the people of municipalities; and

WHEREAS, Article XIII, Section 6 of the Ohio Constitution provides that the General Assembly may restrict a municipalities power of taxation to the extent necessary to prevent abuse of such power, and Article XVIII, Section 13 of the Ohio Constitution states that "laws may be passed to limit the powers of municipalities to levy taxes and incur debts for local purposes;" and

**WHEREAS**, the General Assembly has determined that it is necessary and appropriate to comprehensively review and amend Chapter 718 of the Ohio Revised Code, setting forth statutory requirements for municipal income tax codes in Ohio; and

WHEREAS, more specifically, the General Assembly enacted H. B. 5 in December 2014, and mandated that municipal income tax codes be amended by January 1, 2016 such that any income or withholding tax is "levied in accordance with the provisions and limitations specified in [Chapter 718];" and

WHEREAS, upon a detailed review of H. B. 5 and the Codified Ordinances of the Village of Bluffton, this Ordinance is found and determined by this Council to enact the amendments required prior to the January 1, 2016 deadline to be in accord with the provisions and limitations specified in Chapter 718 of the Revised Code; and

WHEREAS, Council also finds and determines that the constitutionality of certain provisions of the state-mandated code may have been put in question by recent decisions of the Ohio Supreme Court regarding, among other things, taxation of professional athletes, but these provisions must be included if the municipal income tax code is to be "levied in accordance with the provisions and limitations specified in [Chapter 718]" and thus reluctantly are adopted by this Council but are disclaimed to the extent they are unlawful or unconstitutional;

### NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BLUFFTON, STATE OF OHIO, THAT:

<u>Section 1</u>. That Ordinance No. 17-05 the Income Tax Ordinance be amended to read as set forth in the document entitled "Village of Bluffton Income Tax Ordinance" attached hereto as Exhibit A and incorporated herein by reference.

<u>Section 2.</u> That this Ordinance shall take effect and be in force from and after January 1, 2016.

# AN ORDINANCE: TO PROVIDE FOR THE REGULATION OF PARKING ON THE STREETS AND PUBLIC THOROUGHFARES OF THE VILLAGE OF BLUFFTON, OHIO WITH APPROPRIATE PENALTIES FOR THE VIOLATION THEREOF AND TO REPEAL ALL ORDINANCES INCONSISTENT THEREWITH.

- WHEREAS, an Ordinance regulating parking within the Village of Bluffton, Ohio has been brought to the attention of the Council thereof; and
- WHEREAS, the width of the Street does not allow for the unobstructed passage for fire and rescue vehicles or snow removal equipment therefore creating a safety hazard.

### NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BLUFFTON, OHIO:

- Section 1: That it shall be unlawful for persons to park or allow a vehicle to stand upon the streets or public thoroughfares, or portions, thereof, of the Village, on or along the West side of Commerce Lane.
- Section 2: That whoever violates this Ordinance is guilty of minor misdemeanor and shall be fined not more than One Hundred Dollars (\$100.00).
- Section 3: That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

#### Fire Department Tour

Just a reminder that, at the previous Council Meeting, Chief Kinn invited everyone to the Fire Department at 7:30 PM prior to Monday evening's Council meeting for a brief tour of the Fire Department.

#### West Side Interceptor Project

Last week, Dan Bowden, John Bowers and I met with the engineers from CT Consultants to review the proposed plans for the West Side Interceptor project. Over the next couple of weeks, they will be incorporating our input from the meeting into the design plans and further evaluating the estimates for the project. Once we are satisfied with the proposed plans, the engineering plans for the entire project will be submitted to the Ohio EPA for their approval. Once that approval is attained, and a Permit to Install issued by the OEPA, I would like to move forward with putting the project out for bid.

#### **Hydrant Flushing**

The Service Department completed the semi-annual flushing program. There are a few hydrants that will need to be evaluated for possibly needing repairs.

#### Leaf Pickup

As the weather appears serious about changing seasons, we should be transitioning from mowing season to leaf pickup season during the next couple of weeks. As is our norm, we will begin picking up leaves on a part-time basis while also finishing out the mowing season. Depending on the weather and the leaves, we anticipate the leaf pick-up will last through the end of November. Residents should place un-bagged leaves on the side of the street in front of their residence as close to the curb as possible, utilizing the tree lawn if available, and they should not allow the leaf pile to extend into the lanes of traffic. Residents can aid the Service Department by clearing leaves away from catch basins and curb drains. Individuals who park vehicles on the street are asked to be aware of leaf piles when parking their vehicle so that the crews are able to get to the piles of leaves. Village residents are also encouraged to take their leaves to the Village's brush dump at 455 N. Spring Street next to the Maintenance Garage but should not leave leaves in the bag when dropping them off at the brush dump.
