RESOLUTION #23-18

County/Route/Section: ALL/HAN SR 103/235-1.50/7.20

The following is a <u>resolution</u> enacted by the <u>Village</u> of <u>Bluffton</u>, <u>Allen</u> County, Ohio, hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

SECTION I - Project Description

WHEREAS, the LPA has identified the need for the described project:

This project proposes to pave asphalt on the following State Routes:

- SR 103 in Allen County from Main Street to Huber Street in the Village of Bluffton
- SR 235 in Hancock County from CR 313 to SR 12 including work in the Village of Mount Cory
- SR 235 in Hancock County from SR 12 to SR 186 including work in the Village of Benton Ridge
- SR 235 in Hancock County from SR 613 to the Wood County Line including work in the Village of McComb

WHEREAS, a portion of the described project is within the village corporation limits.

NOW THEREFORE, be it Resolved by the Village of Bluffton of Allen County, Ohio.

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

ODOT and FHWA shall assume and bear 100% of the necessary costs of the State's highway improvement project. In the event that the village requests certain features or appurtenances to be included within the State's highway improvement project's design and construction, and which features and appurtenances are determined by the State to be not necessary for the State's project, the village shall contribute 100% of the cost of those items.

SECTION IV - Utilities and Right-of-Way Statement

The LPA agrees that all right-of-way required (if applicable) for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.

The LPA agrees that all utility accommodations, relocations and reimbursements will comply with the current provisions of 23 CFR 65 and the ODOT Utilities Manual.

WHEREAS, the Sherriff of Allen County and the Commissioners of Allen County, Ohio have agreed to provide dispatch services for the Bluffton Police, Fire and EMS for 2019, 2020 and 2021 and;

WHEREAS, an emergency exists in that the parties need to enter into this agreement by the end of 2018 for the preservation of the health, safety and welfare of the Village of Bluffton, Ohio.

SECTION 2. That this resolution is deemed an emergency for the reasons set forth herein and shall be in full force and effect immediately from and after its passage.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

W. Elm Improvements Project: New asphalt in the stone trench!!! Not fully completed, but temporary improvements are here for W. Elm! Roadway reconstruction to begin in March.

<u>Manhole Rehabilitation Project:</u> Preconstruction meeting to be scheduled for the first part of December with possible construction/rehabilitation to begin this year.

<u>Blaze of Lights 2018:</u> Another well-planned and smooth event! Many thanks to all of those who played a role in the event. If you have ideas/suggestions for improvements please share.

<u>SR 103 Railroad Crossing:</u> Representative from Ohio Rail Development Commission (ORDC) conducted an on-site inspection of the crossing with myself and Mr. Lloyd. Choice One has provided the requested plans showing pedestrian crossings on both sides of the tracks. The Diagnostic Review Survey recommendations have been revised to include sidewalk surfaces on both sides of the crossing.

<u>Jefferson St. Water Main Replacement:</u> Choice One has provided three different options for the location of the water line from Huber to Co. Line Rd. Request meeting with Utilities, Streets, and Finance to discuss options.

<u>Jefferson St. Improvements – Phase I:</u> Preliminary plan and profiles were sent to Dominion Gas the week of 11/19 for confirmation of their gas line locations. Design and plan development for the street reconstruction are ongoing. Additional items for future lighting will be added to the plans. Bidding documents to be prepared for bidding in early 2019. Construction to begin July 2019. **Reminder – ODOT will be closing S.R. 103 bridge in April 2019 for replacement. Project scheduled to last 6 months.

<u>Leaf Pick-Up:</u> A reminder to residents who are adjacent to alleys – the leaves need to be placed along the street-side of their property and not along alleys. <u>Leaf pick-up is curb side only</u>. The equipment used to perform the leaf pick-up is not designed for the tight spaces and tight turns that are common in our alley system.

Adopt-A-Family: Once again, Village employees have joined together to adopt a family through the Bluffton Community Assistance Program. We are currently collecting items for the family and if anyone is interested in assisting with this project, please feel free to contact Angle Essinger to find out what is needed. Thank you to those employees and departments who have donated already!
