#### >>> 2016 OFF TO A GREAT START

The BRWP has many projects scheduled for 2016. The first major project is the Rain Barrel Decorating Contest the Partnership sponsors in high schools who have at least part of their district in the Blanchard River watershed. The rain barrels were on display and judged during the Greater Findlay Home Show held at the Findlay Village Mall on March 5th & 6th. This year, eleven schools entered 30 rain barrels. The rain barrels were entered in one of three categories: 1. Watershed Theme, 2. Agricultural Theme and 3. General Theme. Prizes were awarded to the top five rain barrels in each category. There was also a "People's Choice Award" voted by visitors to the Home Show.

Nearly 250 visitors voted for the rain barrel from Riverdale High School as the winner of the People's Choice Award. The barrel is shown in the picture to the right. This barrel from Riverdale H. S. also won First Place in the Watershed Theme category. Other winners in the Watershed Theme category were: Second Place - Arcadia H.S., Third Place - Findlay H.S., Fourth Place - Van Buren H.S. and Fifth Place - Findlay H.S. In the Agricultural Theme category, First Place went to Liberty Benton H.S. Other winners in the Agricultural Theme category were: Second Place - Arcadia H.S., Third Place

#### >>> OTHER PROJECTS IN 2016

The BRWP will be very active in 2016 working with several agencies on various projects. Here are some of the projects for 2016.

- ◆ The BRWP will still have two Great Lakes Basin grants in the Allen County portion of Lower Riley Creek and in Middle Riley Creek watersheds during 2016. Both grants are for Best Management Practices with the farmers. There is still money available. If you are interested, please call Phil Martin at 419-422-6487.
- The BRWP will have displays at the county fairs.
- ◆ The BRWP will also provide a speaker to talk about the importance of great water quality to the economy and the quality of life in an a watershed. If you have a meeting where you need a speaker or a place for our display, please call Phil Martin at 419-422-6487.
- Working with the Hancock County Health Department and the Hancock County Commissioners, the BRWP will help to implement a \$150,000 grants from the Ohio EPA to repair / replace failing Home Septic Treatment Systems in Hancock County. - ◆ The Chemical testing program with the Sierra Club will start in March. Nearly 80 sites will be tested on a monthly basis from March until October. The testing will be done by trained volunteers. Over 15 stakeholders have been trained. The results will be used to help find areas that are impaired. The BRWP will work in the area to find grant money to do the restoration.
- The BRWP will continue to do our Water Quality Monitoring during late June and September. We will again monitor 21 sites on the Blanchard River, Lye Creek, Riley Creek, and Little Riley Creek.

#### >>> BOARD MEMBERS APPOINTED

#### >>> LAKE ERIE ALGAL BLOOM UPDATE

The 2015 Algal Bloom on Lake Erie was a big problem. The 2015 bloom was the largest ever recorded and covered over 500 square miles. The Blanchard River watershed is a headwater watershed in the Western Lake Erie Basin (WLEB) that flows into Lake Erie. The Blanchard River watershed is also a focal watershed for restoration by the Great Lakes Restoration Initiative. There is a great deal of money being poured into the WLEB to help solve the problem. Many agencies are collaborating in the effort to stop the sediment and phosphorus loading to the lake.



#### >>> BLANCHARD RIVER DEMONSTRATION FARMS

The Ohio Farm Bureau Federation (OBF) and the United States Department of Agriculture Natural Resources Conservation Service (NRCS) announced on April 20, 2016, the selection of three farms in the Blanchard River watershed to serve as demonstration farms. The five year project will showcase new and innovative conservation practices designed to reduce and prevent run-off of sediment and nutrients into the waterways. The program is one of the several components of the Ohio Farm Bureau's Water Quality Action Plan. The farms will serve as models to share new conservation techniques and practices with farmers, the media, land managers and the public through Ohio. The first field day is planned for August 26, 2016. Check their web site at www.blancharddemofarms.org or our facebook page at Blanchard River Watershed Partnership for updates.

The three farms will involve several innovative practices including, subsurface nutrient placement and its effect on yields, fertilizer savings using proper timing and placement of cover crops, controlled traffic, conservation tillage, proper storage facilities for on-site fertilizer and fuel tanks, two-stage ditch, no till, blind inlets, filter strips nutrient removal technologies, tile water treatment systems, edge of field testing, and several other possibilities. The farms selected reflect the makeup of agriculture in the watershed regarding crops and livestock, farm sizes, soil types, topography, and current farming practices. (source: media release)


#### >>> BEST MANAGEMENT PRACTICE OF THE QUARTER - NMP

"Nutrient management planning (NMP) is a Best Management Practice or BMP. ... Knowing what you have; Knowing what you need; Managing wisely ... In effect, NMP is much like developing a cash-flow analysis using pounds of N and P instead ..." This quote from an article written by Mississippi State University Extension summarize a BMP that could become required by every farmer in the Lake Erie Basin. Several states require that a farmer have a nutrient management plan for every field on their farm. A NMP is based on the sound principle that lead to the 4R Principles of Nutrient Stewardship - Right Source - Right Rate - Right Time - Right Place.

Nutrient Management Plans can be developed has a part of the Natural Resources Conservation Services (NRCS) as a part of their 590 program. There is some cost-share money available to those farmers who qualify. For additional information, contact your local Soil & Water Conservation District office.

#### >>> TAKING CARE OF OUR WATER

As society becomes more and more aware of the importance of high waterquality, more partnerships are being created that support the mission of the BRWP. One such partnership is "Healthy Water Ohio (HWO)." According to their report, "the economic impact of Ohio's water is in the tens of billions of dollars for businesses, the state's tourism industry and other water uses. The partnership was formed with the input of over 200 people representing almost every walk of life in Ohio. The HWO maintains a web site that can be found at www.healthywaterohio.org. One of the projects has been trying to get legislators to establish a public-private Ohio Water Trust The trust would fund projects for research, monitoring or restoration of gray and green infrastructure and education. #### >>>THINGS YOU CAN DO THIS SPRING AND SUMMER TO HELP OUR WATER



**Apply fertilizers** only when necessary and at the recommended amounts. Spring and Fall are the best time. **BE SURE** to use fertilizer with **NO Phosphorus.** 



Use pesticides, herbicides and other chemicals sparingly. Never double dose! BE DURE to follow directions carefully



**Don't dump** trash or pour any hazardous materials, oil, paint or other chemicals down a storm drain. Storm drains are for rainwater only.



Maintain your septic system. BE SURE to have the tank pumped every 2-3 years. Practice water conservation so as to not over work the system. Don't add tank additives.



Don't wash anything were the soap, chemical or the water will flow into a storm drain. BE SURE the water flows into a drain that will take it the treatment center. Storm drains flows straight to a waterway. Wash you car at a car wash facility.
