>>> 2015 ANNUAL MEETING

The 2015 Annual Meeting of the BRWP was held on November 18, 2015 at the Hancock Agricultural Center on CR 140. Over 40 people attended the 7-9 a.m. meeting. The guest speakers for the meeting were Ryan Sendelbach from the Hancock Health Department, Jason Phillips from the Village of Ottawa and Jeff Giesige / Curt Tobe from the Putnam Soil & Water Conservation District. Each speaker spoke about the involvement of the BRWP with their agency. The BRWP elected representatives to the 2015 Board of Directors representing the Headwaters watershed, Theresa Allen, Ottawa Creek watershed, Don Croy and Tim Macke, the At-Large #2 position. Tim Brugeman, president of the BRWP, show our Emmy Ward winning video "Remember Me." Theresa Allen, VP and 2016 President of the BRWP, talked about "2016 the Future." She mentioned the BRWP's need for funding and the desire of the group to increase the size of the Board of Directors and to form an "Advisory Committee" Watch our facebook page or web site for more information.

>>> Major Projects in 2016

The BRWP will be very active in 2016 working with several agency on various projects. Here are some of the projects for 2016.

- The BRWP is again sponsoring a Rain Barrel Decorating Contest in the area high schools. Thirty three barrels have been entered and will be on display at the Greater Findlay Home Show on March 4^{ht} & 5th at the Findlay Village Mall. Stop and vote for the best barrel. Some of the barrels will be available for sale at the show. (See Picture 1)
- The BRWP will still have two Great Lakes Basin grants in the Allen County portion of Lower Riley Creek and in Middle Riley Creek watersheds during 2016. Both grants are for Best Management Practices with the farmers. Picture 2 shows a field of cover crops planted in the fall of 2015.
- The BRWP will continue to have displays at the county fairs (See Picture 3) and at other area locations. The BRWP will also provide a speaker to talk about the importance of great water quality to the economy and the quality of life in an a watershed. - The Chemical testing program with the Sierra Club will start in March. Nearly 80 sites will be tested on a monthly basis from March until October. The testing will be done by trained volunteers. Over 15 stakeholders have been trained. The results will be used to help find areas that are impaired. The BRWP will work in the area to find grant money to do the restoration.
- Working with the Hancock County Health Department and the Hancock County Commissioners, to the BRWP will help to implement a \$150,000 grants from the Ohio EPA to repair / replace failing Home Septic Treatment Systems in Hancock County. - The BRWP will continue to do our Water Quality Monitoring during late June and September. We will again monitor 21 sites on the Blanchard River, Lye Creek, Riley Creek, and Little Riley Creek.

Board of Directors for 2016

LAKE ERIE ALGAL BLOOM UPDATE

The algal bloom on Lake Eric continued to be a big problem and issue in 2015. The 2015 bloom was the largest ever recorded and covered over 500 square miles. The heavy rains in June led to an higher than average load of phosphorus being carried into the lake from farmland, leaky septic tanks and stormwater and municipal sewage systems whose infrastructure is too old. Board of Directors to Expand

Board Governance Committee

With the emergencies in Toldeo's water supply in 2014 and the emergency being experienced in Flint, MI. with their water supply, high quality water could become the "oil" of the next decade. A survey conducted among 24-30 year olds showed that *High Water Quality was needed for a Higher Quality of Life* in a community.

To this end, the BRWP in July of 2015, with support

from The Findlay-Hancock Community Foundation and guidance from Aly Sterling Philanthopy, formed a Board Governance Committee. The governance committee examines how the board is functioning, how board



members communicate, and whether the board is fulfilling its responsibilities and living up to the objectives and aspirations set for itself and the organization. While all board members should understand the organization's mission and goals, the governance committee must consider them with an eye on the board's responsibility to guide the organization and what is required of the board to best
